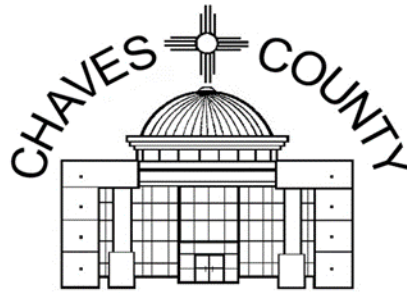

2020 LIVESTOCK REPORTING

Dear Livestock Owner,

It is the responsibility of the taxpayer to report all livestock, located in Chaves County for more than 20 days subsequent to January 1st, to the Chaves County Assessor's Office for property taxation purposes. You are required to complete the attached livestock schedule and return it to our office no later than February 29th (7-36-21 NMSA), so that we can update our livestock records for tax purposes. Even if you no longer own livestock in Chaves County, please complete the attached form so that we may update our records.

If you do not state how many months the livestock will be located in the county, we will tax them for the full year.

Please note that captive deer, captive elk, alpacas & llamas are reportable to the Chaves County Assessor's office as livestock.

If you have a brand registered with the New Mexico Livestock Board, please provide the brand master number on the report where indicated. If you do not own a brand, you may leave this portion blank.
